Treasurer's Report - Peter	 Financials reviewed Budget prep: Take last 5 years and average for a current budget looking at anomalies that might affect the current budget; look at last years actuals & consider using for this year. Fuel will be considerably higher. Can spend up to \$300 without board approval; If something is a budgeted item, can spend up to the amount budgeted 	•
Equipment Report - Bob	 Expenses: We managed to stay close to our 2021-2022 equipment budget (so far) despite a big snow year and long ski season. However, we're going to have to fill the fuel tanks soon and the per gallon costs are looking like they're going to be quite high for 2022-2023. Homer Trails Alliance: There is quite a bit of overlap with KNSC and the Homer Trails Alliance. They are mostly grant funded so far. We have supplemented a recent mower purchase and have agreed to provide ATV hours for mowing. I expect we will continue to work closely together and need to allow for some additional KNSC expensed for equipment and fuel. Snowmachines and ATVs: All Seasons, the Skidoo dealer says the two new Scandic 900 snow machines have shipped; they may have arrived in the latest truckload. Still issues with the McNeil Scandic 900 purchased last year. 	•

	 A volunteer electrician has been found to work on club equipment Mowers: Lookout has the heavy-duty Swisher mower we recently purchased. The two wheeled DR mower has been rebuilt and is at Lower Baycrest. The four wheeled DR mower is still being rebuilt by Peter Roedl. Bill Hague obtained the parts needed for the rebuild. The Homer Trails Alliance purchased a Rammy flail mower. It is designed to be mounted on the front of a 4-wheeler. The KNSC's #15 (2021 model) ATV at Dave Brann's will be the primary machine for mowing with the Rammy. It requires the mounting hardware and a winch on the ATV. The price for the mower was \$4299, plus shipping from Wisconsin. HTA paid for this expense with a grant. KNSC agreed to contribute an additional \$1063 for: extra cutting blades; an ATV mounting bracket, and an offset bracket. Summer Activity: Many trails at McNeil and Lower Baycrest have been mowed this summer. It was very dry the first part of the summer and the trails were quite accessible. The Homer Trails Alliance has done quite a bit of work on the Homestead/Lower Baycrest trails and are doing some more mowing this week. Dave Brann has arranged with Jason Koontz, of Alaska Eco Forestry, to do a mulching/trail clearing demonstration at Lower Baycrest on Sept. 6, 9:00 AM

President's Report - Mike	 Insurance expires at midnight 8/31. Cross Country Ski Areas Association (CCSAA) is @ \$5600/year & covers grooming (groomers & skiers); they may have Directors & Officers insurance Mike looked at several insurance options including Frasier who was basically our previous insurance to whom we paid @\$2000/year, but it may not cover grooming or offer Director & Officers insurance Milli Martin - Milli has approx. 240 acres she'd like to donate for use as a park for hikers, skiers, and equestrians. The logistics are complicated determining who would be the landowner and then who would be the manager or steward of the land. Lauren Rusin (Kachemak Land Trust) has been trying to coordinate the various entities. There is a possibility KPB borough could own the land with a Community Trail Management Agreement amongst the user groups. Marcus Mueller (KPB Land Manager), Milli Martin, Lauren Rusin (Kachemak Land Trust) and Mike are meeting to investigate what the borough needs, what the land trust needs, and what KNSC can offer Lookout work – John Miles requested \$2000 for cutting alders 	 When Mike gets a quote and details from Fraizier, he will choose a provider that meets KNSCs needs Approved Lookout request for \$2000

An invasive species panel has just arrived and will be installed before the end of the season. A new kiosk was installed at the beginning of June.
